Mayor Matthews noted that we have a serious situation in our community regarding roaming cats. 21 cats have already been taken from the Greenwood Avenue area and there are 3 or 4 more problem areas in Town with a large number of cats. It was noted that the veterinarian won't euthanize a cat that he don't think is ferial.

It was also agreed that an email would be forwarded reminding citizens to not feed stray cats.
